CHAMPIONSHIP DATE AND SITE

Saturday, November 28, 2009 - Woodward Park, Fresno

NOTE: Competitors will not leave school on the day preceding the competition prior to the close of the school day unless travel requires two days. If travel requirements warrant, schools may petition their section CIF office for the additional day. Violation of this regulation may result in disqualification.

IN CASE OF A NATIONAL EMERGENCY – CHANGE IN TERROR ALERT STATUS

If, prior to or during the State CIF Championships, there is a change in the Terror Alert Status or a National Emergency, all schools, administrators, coaches, parents and athletes should go to the CIF State web site at www.cifstate.org for the latest information. The State CIF and all of our championship venues work closely with local and national law enforcement authorities and Homeland Security prior to making any determination on postponing, canceling or continuing with the championships.

STATE CHAMPIONSHIP DIVISIONAL PLACEMENT OF SCHOOLS

Each Section will determine the divisional placement for its schools who qualify for the state cross country championships and is required to submit the placement of schools into the five divisions to the State CIF Office no later than October 1. CIF-member schools will be required to participate in the division that has been established by their respective Section. Sections may use their own established criteria to determine placement of teams in the five divisions based on the following guidelines:

- Division I As determined by Section
- Division II As determined by Section
- Division III As determined by Section
- Division IV * As determined by Section, but enrollment may not exceed 1,250
- Division V * As determined by Section, but enrollment may not exceed 500

(Revised May 2008 Federated Council)

** The following information relates to Divisions IV and V only.*

Note: Grades 9-12 are utilized for CBEDS enrollment.

Single Gender Schools - The enrollment for single gender schools shall be doubled in grades 9-12 to gain a total figure for the single gender school.

INTRODUCTIONS

All 2009 Section champions and returning state champions, will be introduced **10 minutes** prior to the start of their race. Please make contact with announcer when you arrive at the park. Please have your athletes at the introductions **15 minutes** prior to race time.

AWARDS

- (a) **TEAM AWARDS** - Plaques for champion, runner-up, and third place team
Medals 1st through 7th for championship team, runner-up, and third place
- (b) **INDIVIDUAL AWARDS** - Individual medals 1st through 10th runner, each division
- (c) **CERTIFICATES** - will be awarded to all participants plus up to two alternates
- (d) **SPORTSMANSHIP/CITIZENSHIP AWARD** – Sportsmanship/Citizenship medals will be awarded to student-athletes who demonstrate exemplary sportsmanship and citizenship throughout the season. Coaches are encouraged to forward worthy nominees to the State CIF office.

AWARDS CEREMONY

Please have your medal winners (top 3 teams/top 10 individuals per division) **in school-issued uniform** at the awards ceremony **15 minutes** prior to presentation times.

PLEASE NOTE: ONLY YOUR 7 ATHLETES WHO COMPETED IN THE STATE CHAMPIONSHIP RACE ON NOVEMBER 28, 2009, ARE TO GO UP ON THE STAGE TO

RECEIVE MEDALS. *The rest of your team is invited to be in the audience to support the team ... BUT ONLY PARTICIPATING RUNNERS WILL BE ALLOWED ON STAGE.*

COURSE AND RUNNING SURFACE

- (a) All races will be 5,000 meters.
- (b) The course is in Woodward Park on hard-packed dirt trails with some grass and asphalt. It has mild ups and downs over rolling hills with one steep short hill.
- (c) Many major cross country meets have been run on this course (Foot Locker National Meet, State J.C., Regional and District N.C.A.A. Meets).
- (d) No spikes are allowed on this course.
- (e) **Meet will be run - rain or shine.**

AUTOMATIC TEAM ENTRIES (Bylaw 1701)

Team entries into the state championship meet are based on a formula that includes two factors: 1) An established baseline providing a minimum number of entries for each Section.
 2) Additional entries based upon the most recent four-year history of the Section team performance in each divisional race. No Section shall have more than seven team entries in any divisional race.

NOTE: Sections must have eight (8) or more eligible schools competing in a given classification in order to qualify for the maximum number of automatic entries in that classification. An eligible school is interpreted to mean “schools with five or more athletes who have qualified to compete in a Section prelim or finals. Section offices will verify this information by October 1, 2009, with the State office.

Qualifications from sectional competition to the CIF State Cross Country Championships as an **individual entry** are based upon **individual place finish**. Qualifying teams plus the top five highest placed individuals (not on a qualifying team) as per the criteria above in each division will qualify from section to state meet finals.

NOTE: There are no alternates for the state meet.

OFFICIAL RULES

2009 National Federation Cross Country Rules (located in Track and Field Rules Book) are official and will be enforced. *"All individual runners and teams must be accompanied by a certified person from the school district."*

UNIFORMS

National Federation Rules 9-6-1, 9-6-2, 9-6-4, 9-6-5 and 9-6-7 regarding uniforms will be enforced.

If your team is planning on using a new, or different school uniform for the state meet, please make sure the uniform adheres to CIF and National Federation uniform rules. For questions, contact rules interpreter Hal Harkness at 714-529-6938.

NOTE: All runners must wear their competitor's number on the front of their jersey and on no other place.

Face and Body Decorations are Prohibited:

An athlete who has visibly decorated/painted any part of his/her face or body will not be allowed to enter the clerk/starting area until all traces of any decoration(s) have been completely removed. This does not apply to hair color.

COACHES PACKETS

The coaches of a qualified team or individual may pick-up their packets on **Friday, November 27, 2009**, at Woodward Park from **12 noon - 5 p.m.** OR at **Woodward Park after 7:00 a.m.** on Saturday, November 28, 2009, at the **Coaches/Athletes Entrance**. Only the coaches' names that appear on the section qualifying entry form will be allowed to receive that school's packet.

NAMES AND NUMBERS

FINISH CORRAL (CHUTE) PROCEDURES (NEW THIS YEAR)

1. The runners will each have corresponding timing chips one attached to each shoe. Directions on this procedure will be given at packet pick-up. The usual corresponding bib and hip numbers will also be in the packet and will be required to be worn on chest (bib) and right hip each with 4 pins. **All ATHLETES MUST WEAR THE CORRESPONDING SAME NUMBERED CHIPS, BIB AND HIP NUMBER.**
If you have any extra chips that your team did not turn in either before the race starts or at the end of their race (i.e. runner not participating, or runner not finishing the race, etc.), you must return the those chips at packet pick-up or coaches corner because your school will be billed \$25 per non-returned chip (\$50 per runner).
2. The finish chute (now called the finish corral) will be composed of mat like sensors. The runners are to run across all mats and continue running approximately 10 feet beyond the last mat to where two officials will be waving red flags. Any runner who stops or walks will be physically removed from this zone.
3. Once the runners have reached the red flags, they may disperse and walk. They do not have to stay in finish order once they clear the sensor mats. At this point they DO NOT have to stay in order of finish.
4. They are to disperse and find an empty chair, remove the timing chips from their shoes and return them before leaving the corral. We will make every attempt to not be allow athletes to leave the corral until their chips have been turned in.
5. There will be no collection of the bib numbers (tear off section will not be used due to timing chips).
6. Each school will be billed \$25.00 for each lost or non-returned chip (\$50 per runner). The CIF will collect this fee from each school not returning a chip(s).
7. Year and/or spelling corrections and substitution of a runner may be done as usual at packet pick-up. Be sure to bring the **bib number of the runner!!!!**
8. The name that is in the database will be reflected in the results unless changed at packet pick-up.

Coaches **MUST** go over the above procedures with their runners.

Please double-check your athlete's name(s) and school affiliation. If a team is substituting a runner or any spelling errors occur, please inform an official at the packet pick-up area by bringing the **chest number with necessary corrections** and they will take down the information to give to Bob Rush. Changes with Bob Rush may also be done on Friday from **12:00-5:00 p.m.** at Woodward Park.

DO NOT CALL THE STATE CIF OFFICE WITH THESE MINOR CORRECTIONS.

DO CALL, IF YOUR ATHLETE WAS AN INDIVIDUAL WHO WAS INADVERTANTLY LEFT OFF THE LIST OF ENTRIES.

REMEMBER: A maximum of 7 runners can be entered. There are no alternates.

If a TEAM (alternate/substitution) or correction(s) is necessary, do it when you pick-up your packet on Friday. Team entries can be changed. Please see Appendix D.

CHECK-IN/STARTING LINE ASSIGNMENTS

Enclosed in your entry packet will be starting line assignments. Please have your athletes at the starting line **20 minutes** prior to race time for check in. The starting line must be cleared of all coaches **5 minutes** prior to race time.

Please make sure that ALL of your runners have their corresponding chips, bib and hip numbers attached accordingly. Chips must be securely laced on each shoe. Bib numbers on the chest with pins. Hip numbers on the right hip with pins as well.

STARTING AREA

Please help us to keep the starting area free of spectators to allow the runners ample room to warm up.

SCORING PROCEDURES

- (a) Scoring, placement and timing will be done in accordance with NFHS. It is imperative that all runners wear their assigned corresponding chips, bib and hip numbers. If a runner does not wear or loses his/her chips then they will not be recorded and scored in the results unless an appeal is filed, in which a video and photo finish review will be conducted. At that time, the runner's bib and hip numbers will be used to determine the appropriate place and time. NFHS Rule 9-3-3 states, "Computerized chips may be used to record the finish of a runner in cross-country, provided the chips are attached to both shoes of the runner. When chips are used, it is the position of the chip, not the torso, that determines the finishing position of the runner."
- (b) Meet results will be posted thirty (30) minutes after the finish of each race. Only one copy of the typed results for each division will be available following the awards presentation. Enclosed in your packet is a results ticket for your division. Additional copies will be sold for \$1.00.
- (c) Scoring will be in compliance with the 2009 National Federation Rules. (Five {5} score and Two {2} displace).
- (d) Section 2 – Article 4 – Ties in team scoring shall be resolved by comparing the sixth place finishers from tying teams. The team with the best sixth place finisher shall prevail. If one team does not have a sixth finisher the team with a sixth place finisher shall prevail.

COACHES CORNER

If you need answers fast, go to the Coaches Corner.

ADDITIONAL SAFETY PINS

Additional pins will be available at Coaches Corner.

ATHLETE CONDUCT

Notify your athletes to refrain from throwing footballs, Frisbees, etc., around the start/finish and awards area. All athletes are expected to "Pursue Victory with Honor" and follow the CIF Codes of Conduct.

RESTROOMS

Restrooms are located throughout the park, but please come dressed to run.

MOPEDS, BICYCLES, ETC.

Mopeds, bicycles, and other similar forms of transportation to traverse the course are restricted. Vehicles of this type should be limited to the paved roadway, and at no time be in position to interfere with runners or the normal operations of the meet. At this meet, the start/finish area gets extremely congested and will be closely monitored. Thank you for your cooperation.

WATER/LIQUID REMINDER

Meet management, or individual coaches, may provide water/liquids during a cross country race as long as **it has been announced before the start of the race, and regardless of whoever is providing water/liquids; they are equally available to all runners, regardless of team affiliation.** A coach/school may not provide water/liquids for only their runners.

DISQUALIFICATION

The CIF will consider disqualifying a runner or team only if a meet official detects or can verify the infraction. Meet management **will not** rely on information provided by non-officials. If you have a

concern or complaint, contact Meet Director, **Marty Simpson**, or **Dave Dodson**, through the Coaches Corner.

COURSE MAPS

The course map is enclosed in this bulletin. Please feel free to ask for clarification.

EMERGENCY MEDICAL CARE

Medical care will be available for emergencies only. Athletic trainers will NOT be available for taping or massaging of athletes. Trainers will be out on the course during races and also will be available at the Mt. View Shelter.

IT IS THE COACHES RESPONSIBILITY TO ENSURE THAT COMPETITORS WHO USE “INHALERS” HAVE THE COMPETITORS INHALER DURING THE RACE AND MUST BE PRESENT AT THE FINISH LINE AREA.

ENTRANCE/PARKING/CONCESSIONS

- (a) **Athletes, coaches and officials - Entrance to Woodward Park will be at the North East gate off Friant Road only** (see map).
- (b) Spectator’s entrance to Woodward Park will be at the South Gate off Audubon.
- (c) Admission charges: **General Admission - \$10.00 CHILDREN - \$5.00**
Coaches must present ribbon and athletes their race number to be admitted to the park. Pre-race admission tickets will be sold Friday, November 27, at Woodward Park, Mt. View Shelter, from 12 noon - 4:00 p.m. Parking is allowed in designated areas only. All vehicles parked illegally, inside or outside of the park, will be ticketed and towed. Do not park on any grassy areas inside the park.
- (d) A concession stand will be available at the park.

CIF MERCHANDISE

A souvenir concession stand will be open race day from 8 a.m. - 3:30 p.m. It also will be open at Woodward Park at Mt. View Pavilion from 12 noon - 5 p.m., Friday, November 27. T-shirts, sweatshirts, patches, pins and other cross country materials will be on sale. Supply is limited to those on hand.

SOUVENIR PROGRAM

Souvenir programs will be available for purchase at Woodward Park on Friday, November 27, from 12 noon – 4:00 p.m., as well as all day Saturday. The program will include all entered participants and numerous photos of student-athletes from across the state.

Help for the program is requested. Coaches are asked to submit **action photos** of top student-athletes **NO LATER THAN WEDNESDAY, NOVEMBER 5**. MEDIA CREDENTIAL REQUESTS

Requests for media credentials must be made on the appropriate credential request form and received by the State CIF office no later than Tuesday, November 24, 2009, at 12 noon. Credential request forms will be sent via the State CIF email distribution list and also will be available on the State CIF web site (www.cifstate.org) under the “Media” link. Late requests for credentials will not be accepted. Approved media members may pick-up their credential Friday, November 27, from 12 noon – 4:00 p.m. at the Coaches Packet Pickup area at Woodward Park. Media who do not claim credentials Friday, will need to show their media affiliation identification to gain complimentary entrance to the park on Saturday, and then come to the working press area to obtain their credential.

NOTE: Due to limited space in the finish line chute, media WILL NOT be allowed in the finish line chute area under any circumstances. Only photographers with proper credentials will be allowed access to the finish line chute and only for the purpose of taking photos (not interviewing athletes). Anyone seen violating this policy will be asked to leave the finish line chute area.

MEDIA PARKING

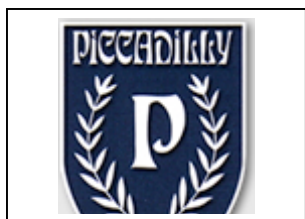
Credentialed media are requested to enter Woodward Park at the **spectator entrance**. Parking is complimentary to all credentialed media in the designated area, provided they show proper identification.

PRESS FACILITY

A covered, outdoor working press area will be available near the finish line. There are electrical outlets for media use, but no telephone service is available at Woodward Park. Results will be distributed at the press area approximately 30 minutes following the conclusion of each race. Media are responsible for securing their own interviews with athletes and/or coaches.

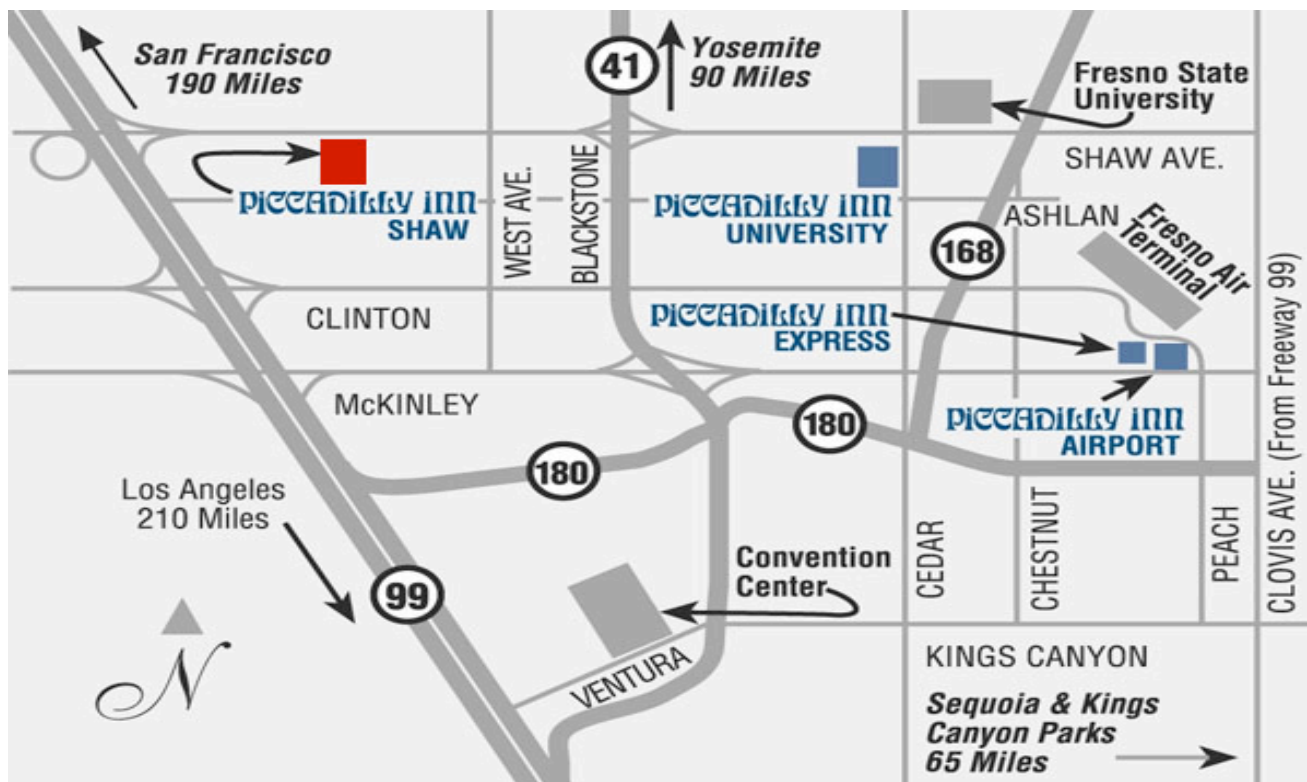

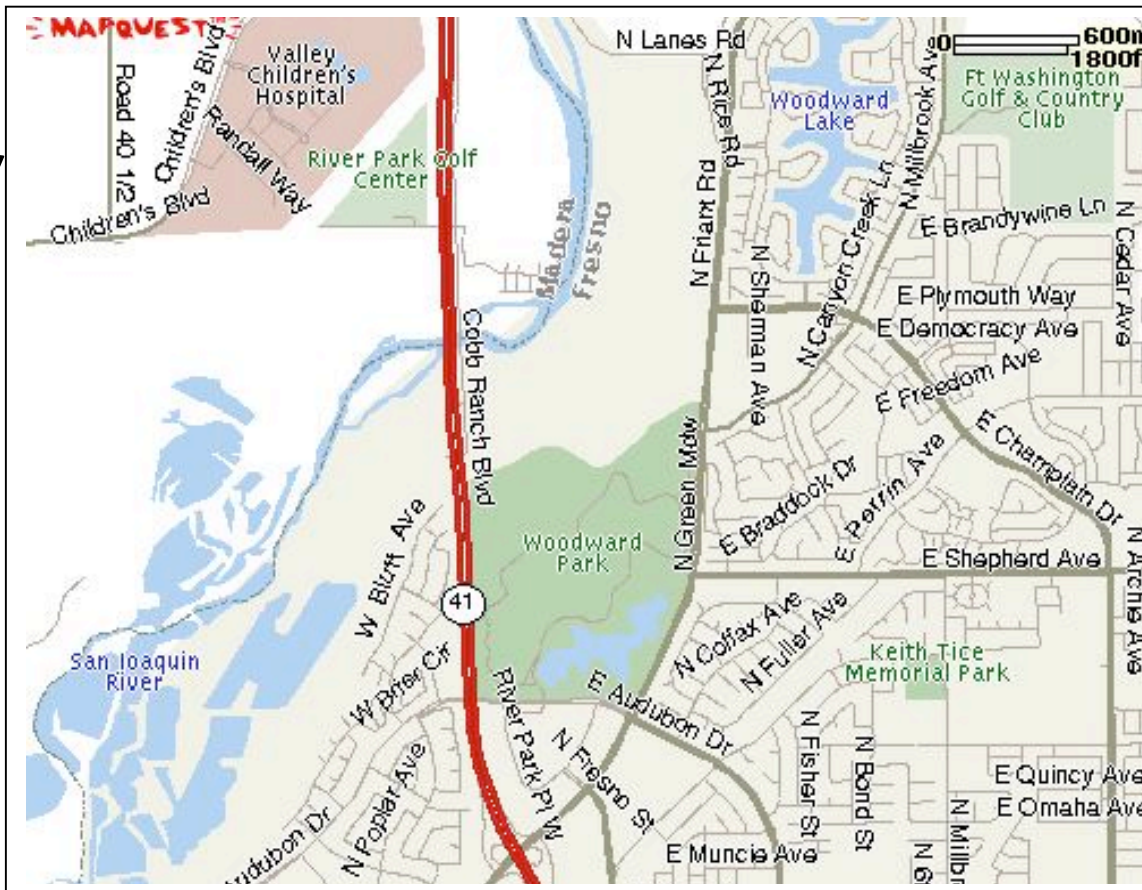

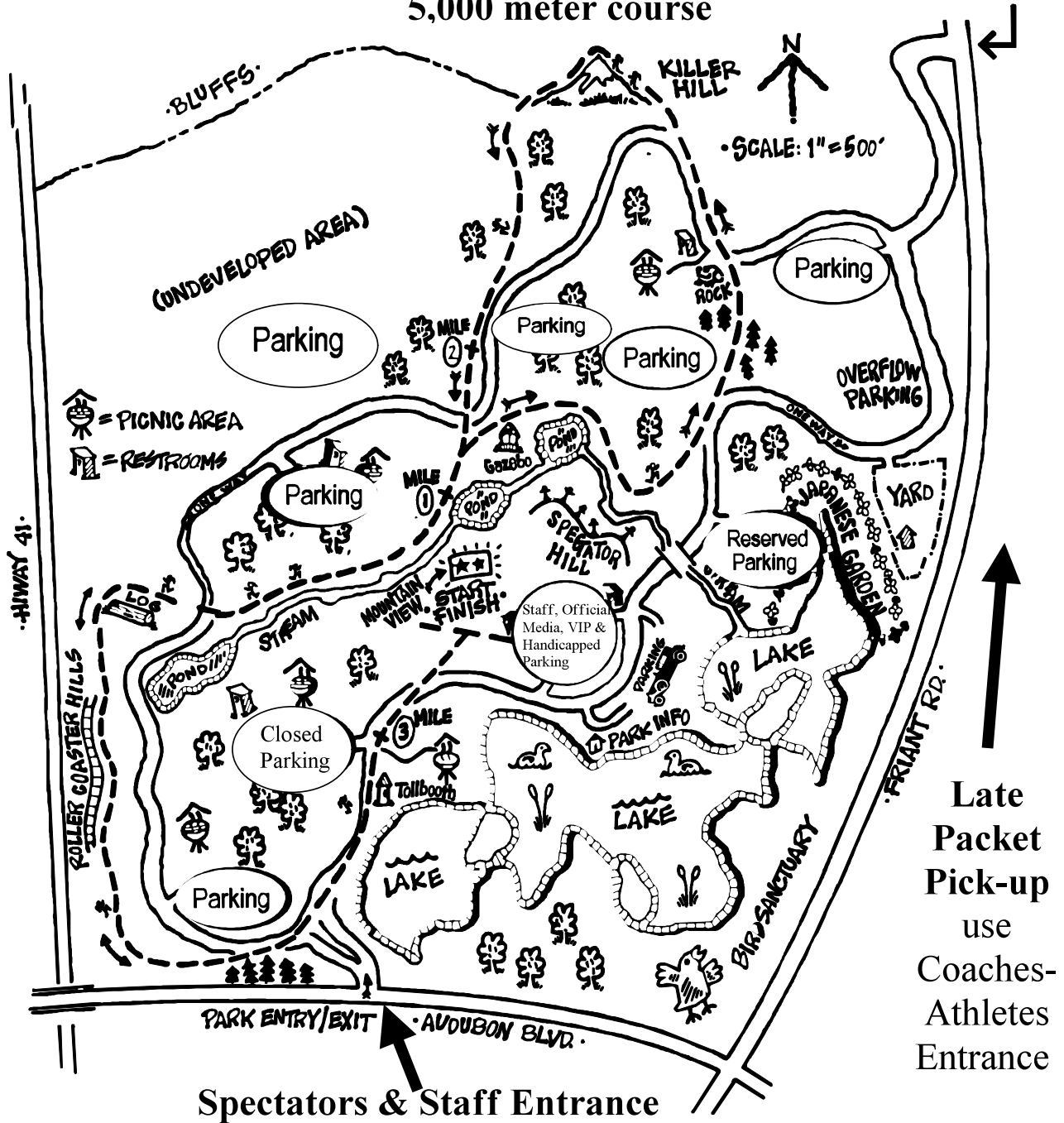


WOODWARD PARK MAP
